D. RESOLUTION DETERMINING TO PROCEED WITH THE SUBMISSION TO ELECTORS OF THE SCHOOL DISTRICT A SUBSTITUTE LEVY

The Board of Education of Sheffield-Sheffield Lake City School District, Ohio, met on January 14, 2019, at the meeting held immediately after the organizational session, which session commenced immediately after the budget hearing starting at 5:30 p.m., in the Board of Education Conference Room, 1824 Harris Road, Sheffield, Ohio, with the following members present:

The notice requirements of Section 121.22 of the Revised Code and the implementing rules adopted by the Board pursuant thereto were complied with for the meeting. ______ moved the adoption of the following resolution:

RESOLUTION NO.

A RESOLUTION DETERMINING TO PROCEED WITH THE SUBMISSION TO THE ELECTORS OF THE SCHOOL DISTRICT OF THE QUESTION OF A SUBSTITUTE TAX LEVY PURSUANT TO SECTION 5705.199 OF THE REVISED CODE.

WHEREAS, at an election on May 6, 2014, the electors of the School District approved the renewal of all of an existing tax levy in excess of the ten-mill limitation in order to raise the amount of \$2,300,000 each calendar year for a period of 5 years for the purpose of providing for the emergency requirements of the School District, pursuant to Sections 5705.194 through 5705.197 of the Revised Code, the last collection of which will occur in calendar year 2020 (the Existing \$2,300,000 Levy); and WHEREAS, at an election on May 6, 2014, the electors of the School District approved the renewal of all of an existing tax levy in excess of the ten-mill limitation in order to raise the amount of \$1,894,000 each calendar year for a period of 5 years for the purpose of providing for the emergency requirements of the School District, pursuant to Sections 5705.194 through 5705.197 of the Revised Code, the last collection of which will occur in calendar year 2020 (the Existing \$1,894,000 Levy); and

WHEREAS, at an election on May 5, 2015, the electors of the School District approved the levy of an additional tax levy in excess of the ten-mill limitation in order to raise the amount of \$1,985,000 each calendar year for a period of 5 years for the purpose of providing for the emergency requirements of the School District, pursuant to Sections 5705.194 through 5705.197 of the Revised Code, the last collection of which will occur in calendar year 2020 (the Existing \$1,985,000 Levy and, together with the Existing \$2,300,000 Levy and the Existing \$1,894,000 Levy, collectively, the Existing Levies); and

WHEREAS, on December 10, 2018, this Board adopted Resolution No. 18-270 determining to submit to the electors of the School District, pursuant to Section 5705.199 of the Revised Code, the question of a levy in excess of the ten-mill limitation in the initial annual amount of \$6,179,000 for the purpose of providing for the necessary requirements of the School District in substitution for all of the three Existing Levies, a copy of which resolution was certified to the Lorain County Auditor; and

WHEREAS, on December 18, 2018, the Lorain County Auditor certified that the total current tax valuation of the School District is \$310,858,760 and the annual tax levy required to produce the annual amount of \$6,179,000 in the initial year of collection of the substitute levy, calculated in the manner provided by Section 5705.195 of the Revised Code, is 19.88 mills for each one dollar of valuation, which amounts to \$1.988 for each one hundred dollars of valuation;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Sheffield-Sheffield Lake City School District, County of Lorain, Ohio, that:

Section 1. Determination to Proceed. This Board determines to proceed with the submission to the electors of the School District, pursuant to Section 5705.199 of the Revised Code, at an election to be held on May 7, 2019, the question of a substitute tax levy in excess of the ten-mill limitation (commencing with a levy on the tax list and duplicate for tax year 2019 to be first distributed to the School District in calendar year 2020) in order to produce the amount of \$6,179,000 in its initial year and an amount equal to the sum of the following in each subsequent year: (a) the dollar amount derived from the levy in the prior year and (b) the dollar amount equal to the then-current year, excluding carryover property as defined in Section 319.301 of the Revised Code, multiplied by the annual levy, expressed in mills for each one dollar of valuation, that was required to produce the annual dollar amount of the levy in the prior year; provided, that in

no event shall the amount under this clause (b) be less than zero, for the purpose of providing for the necessary requirements of the School District, at the annual Tax rates necessary to produce those amounts, which rate is estimated by the Lorain |County Auditor to be 19.88 mills for each one dollar of valuation, which amounts to \$1.988 for each one hundred dollars of valuation, for the initial year, for a continuing period of time.

Section 2. Certification and Delivery of Materials to Board of Elections. The Treasurer is hereby directed to deliver or cause to be delivered (i) a certified copy of Resolution No. 18-270, referred to in the fourth preamble to this Resolution, (ii) the certificate of the Lorain County Auditor referred to in the fifth preamble to this Resolution, and (iii) a certified copy of this Resolution, to the Lorain County Board of Elections before the close of business on Wednesday, February 6, 2019. This Board requests that the Board of Elections prepare the ballots and make other necessary arrangements for the submission of this question to the electors of the School District, all in accordance with law.

Section 3. <u>Compliance with Open Meeting Requirements</u>. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this Resolution were taken, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were held, in meetings open to the public, in compliance with the law.

Section 4. <u>Captions and Headings</u>. The captions and headings in this Resolution are solely for convenience of reference and in no way define, limit or describe the scope or intent of any Sections, subsections, paragraphs, subparagraphs or clauses hereof.

Section 5. <u>Effective Date</u>. This Resolution shall be in full force and effect immediately upon its adoption.

NOTICE OF ELECTION ON TAX LEVY IN EXCESS OF THE TEN-MILL LIMITATION

Notice is hereby given that pursuant to resolutions adopted by of the Board of Education of Sheffield-Sheffield Lake City School District, Ohio, on December 10, 2018, and January 14, 2019, there will be submitted to a vote of the electors of said School District at an election to be held in said School District at the regular places of voting therein, on Tuesday, May 7, 2019, the question of a tax outside of the ten-mill limitation pursuant to Section 5705.199 of the Revised Code for the purpose of providing for the necessary requirements of the School District in substitution for three existing emergency tax levies of the School District tax is to produce the amount of \$6,179,000 in its initial year, to increase in amount in subsequent years only if and as new land or real property improvements not previously taxed by the School District are added to its tax list, and to run for a continuing period of time, beginning with a levy on the 2019 tax list and duplicate, for first collection in 2020. Upon approval of the substitute levy, the three existing emergency tax levies would not be levied after the year preceding the year in which the substitute levy is first imposed. Said tax constitutes a substitute levy.

The estimated tax outside of the ten-mill limitation necessary to raise the annual amount of \$6,179,000 in the initial year of the levy as certified by the County Auditor is 19.88 mills for each one dollar of valuation, which amounts to \$1.988 for each one hundred dollars of valuation.

If approved, any remaining tax years on any of the three existing levies will not be collected after tax year 2018 (collection year 2019).
